Note: By the terms of the Workmen's Compensation legislation, compensation could be paid in weekly sums or else by a lump sum payment. It served the interests of employers to persuade impaired workers to commutate their claims and receive lump sum payments in place of weekly benefits but, while this suited some workers, miners' trade unions did not believe that workers gained by this and so encouraged recipients of compensation to retain their weekly payments rather than commutate their claims.
